Tillaga að fjárhagsáætlun fyrir árið 2014 var lögð fram í bæjarstjórn í október. Í henni var miðað við að rekstrarafgangur yrði um 642 milljónir kr. á næsta ári. Í áætluninni var m.a. lagt til að fasteigna-skattur á íbúðarhúsnæði yrði lækkaður annað árið í röð og að skuldir yrðu áfram lækkaðar um rúma tvo milljarða að teknu tilliti til verðbóta.

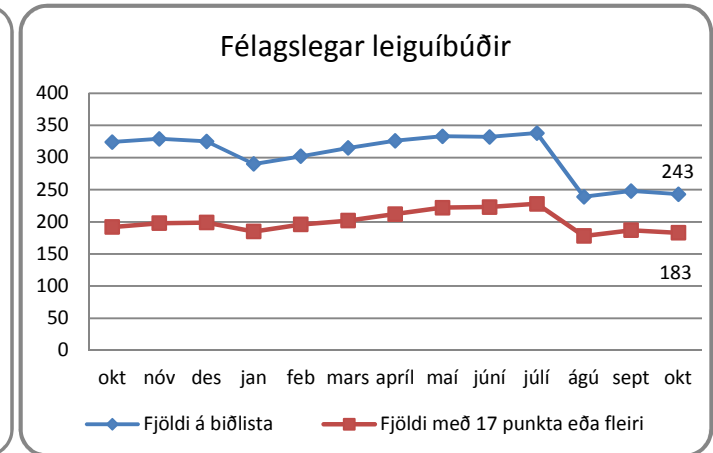
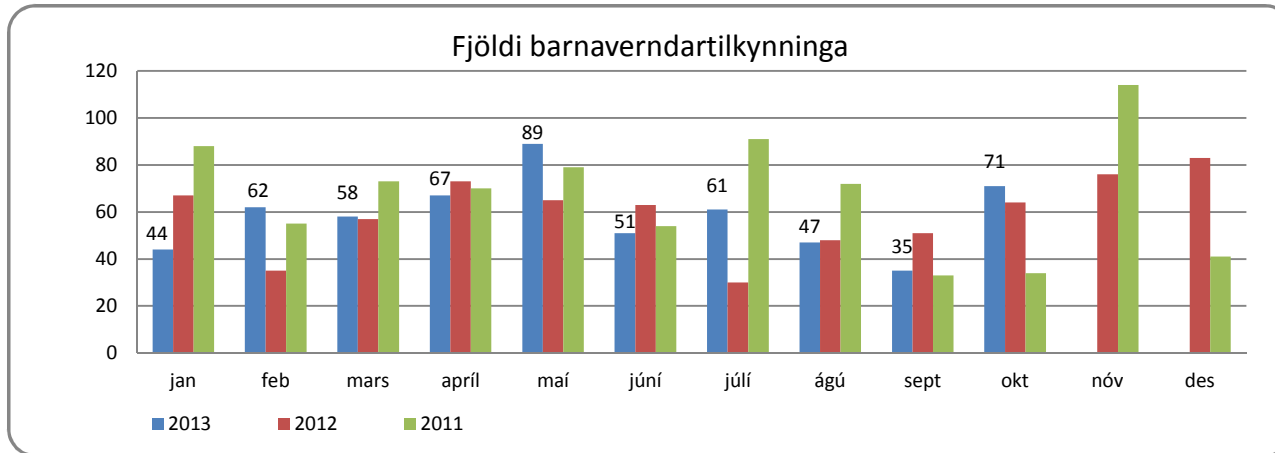
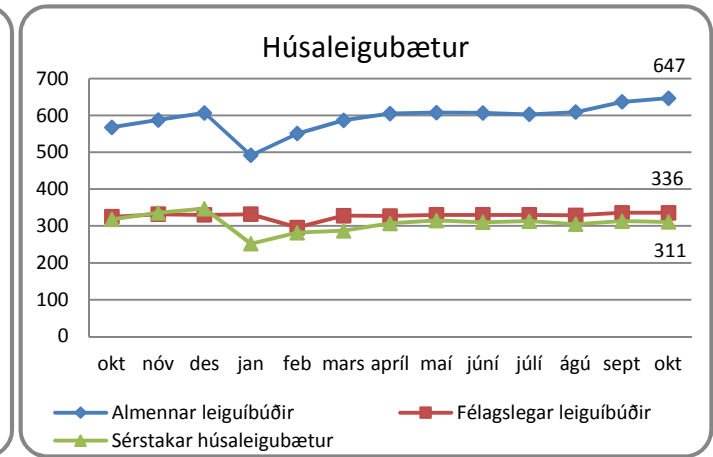
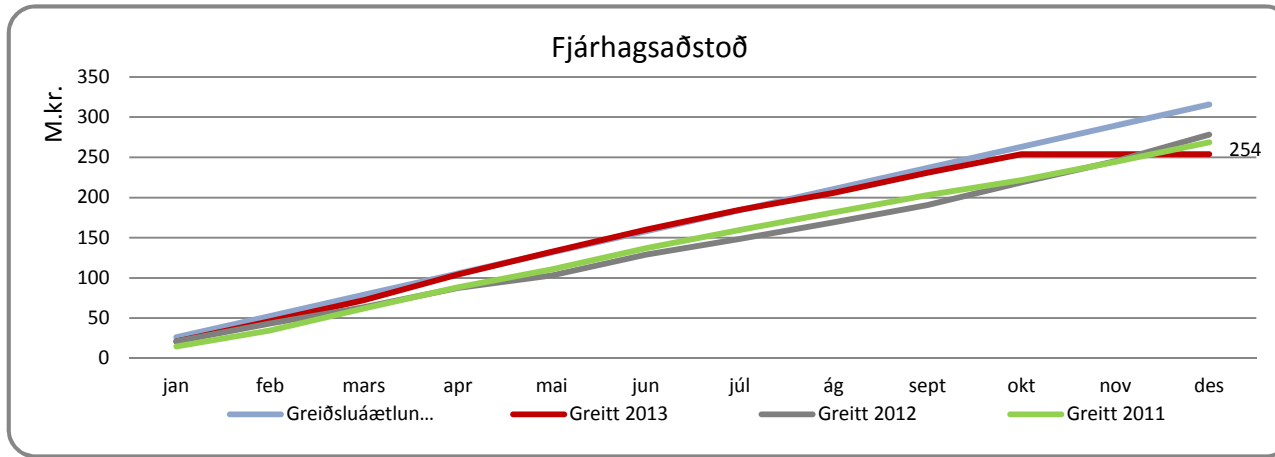

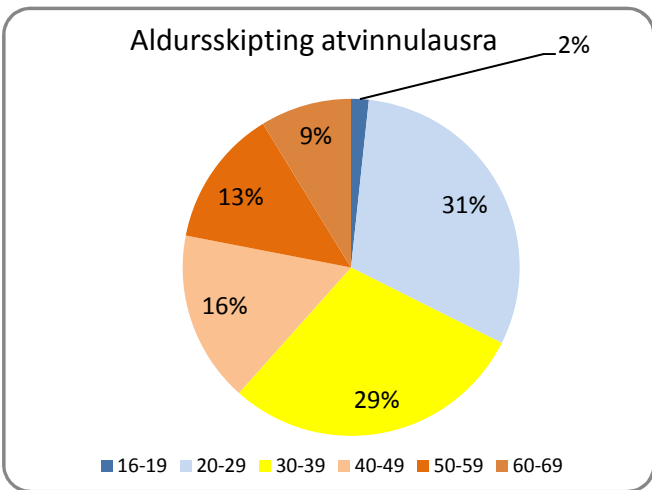
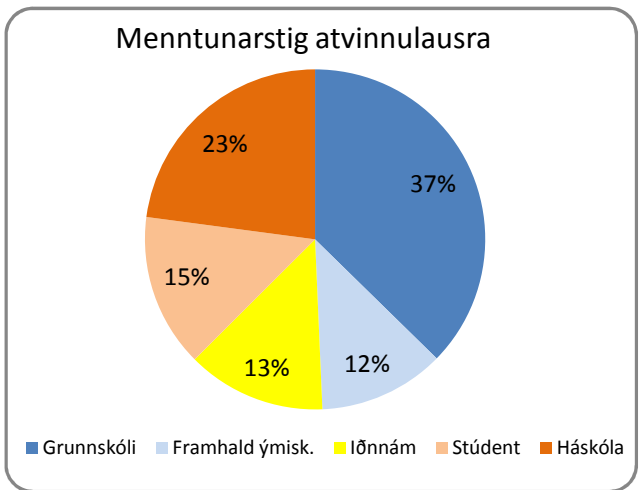
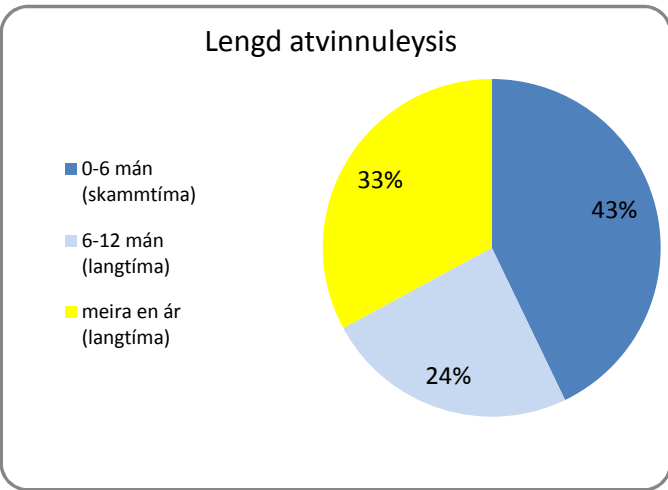
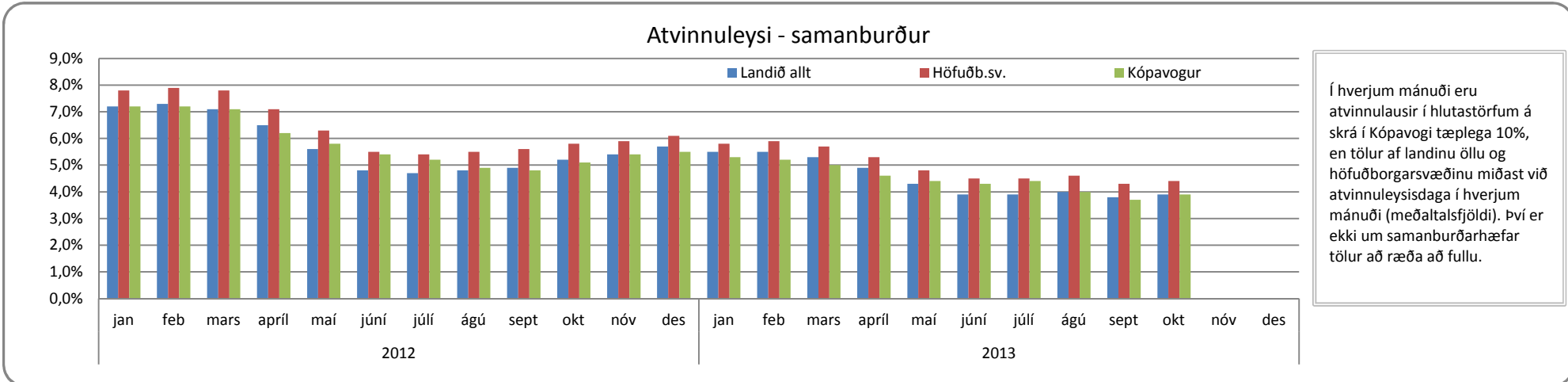
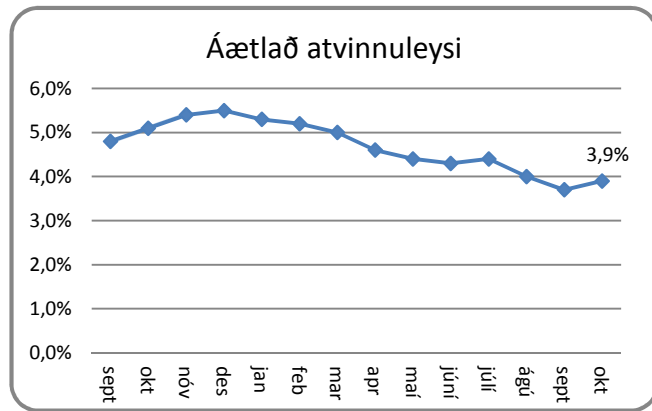
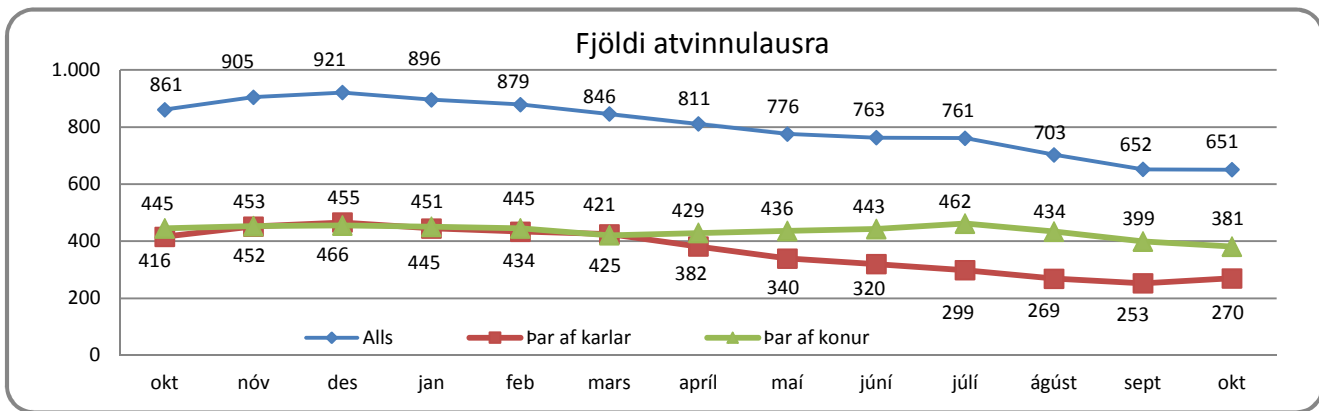
Kópavogsbær og Listaháskóli Íslands gerðu með sér samkomulag um að útskriftarsýningar meistaranema í myndlist og hönnun yrðu haldnar í Gerðarsafni. Meistaránám í myndlist og hönnun við LHÍ hófst haustið 2012 og brautskráir skólinn fyrstu nemendur námsbrautanna tveggja næsta vor. Fyrsta útskriftarsýning meistara-nemanna verður því í apríl 2014. Samningurinn nær til þriggja ára.
