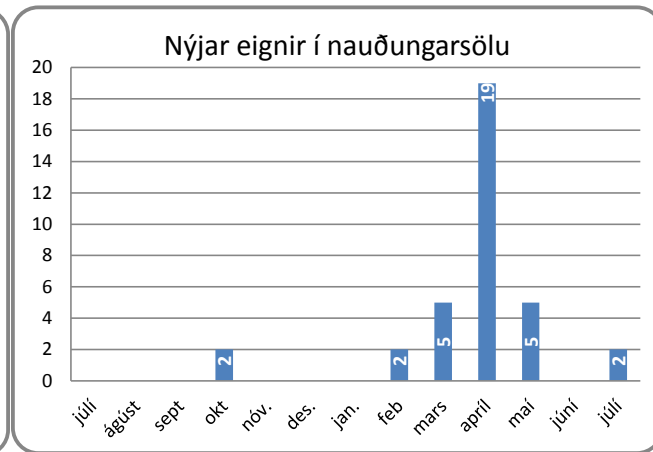
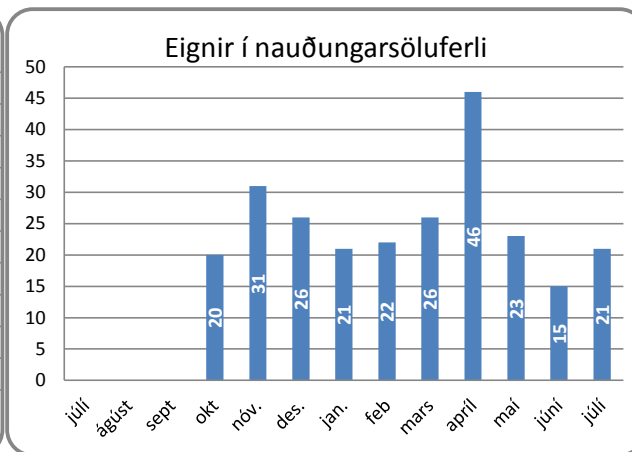
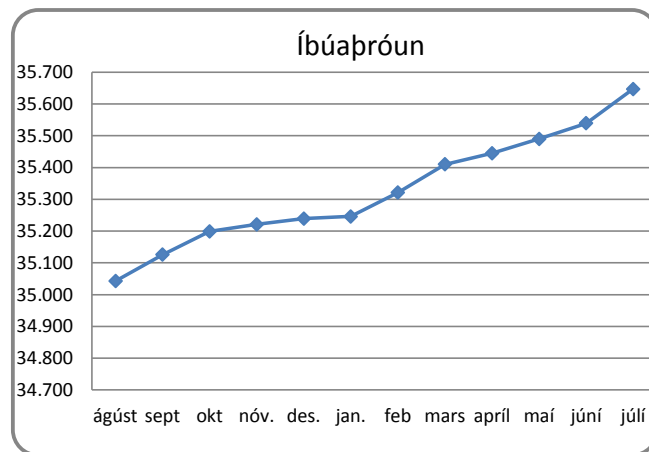
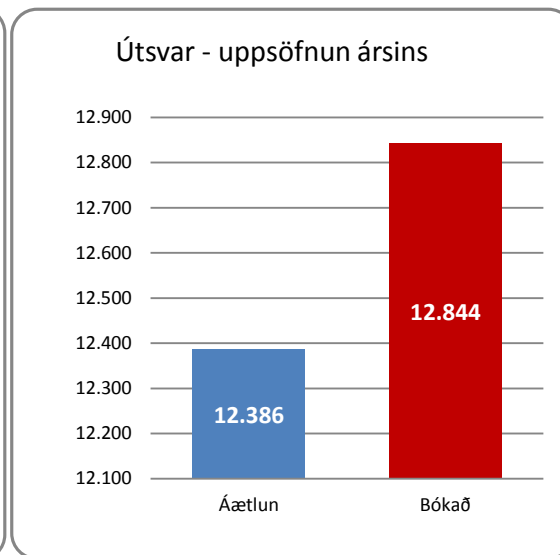
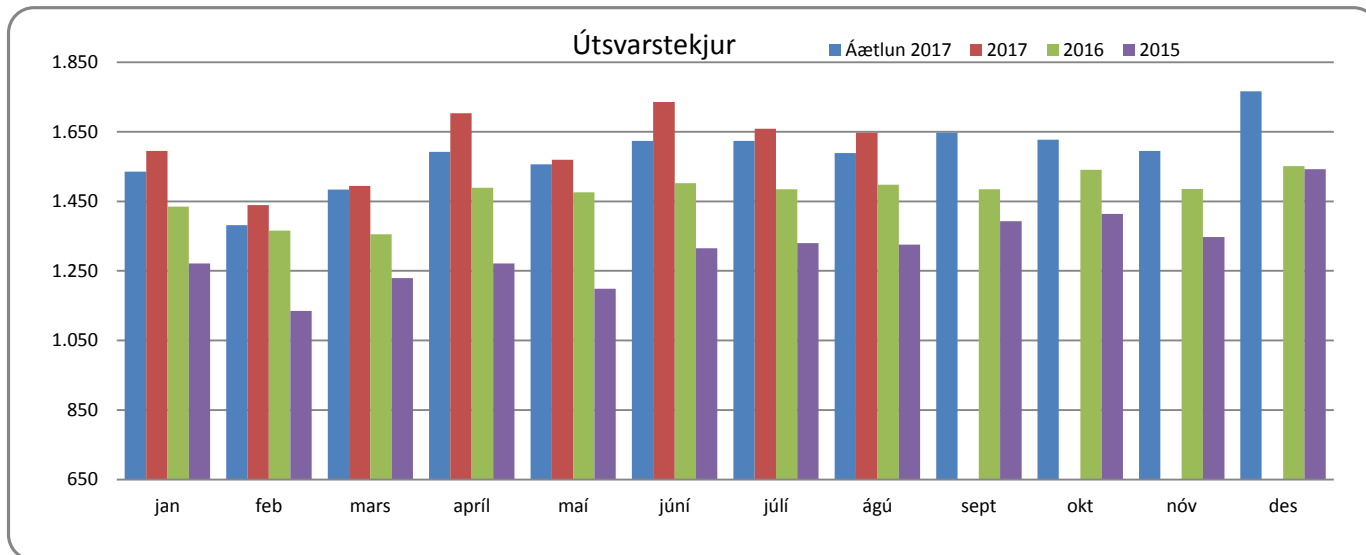
Þjónustuver Kópavogs flutti að Digranesvegi 1 úr Fannborg 2 í ágústbyrjun. Bæjarskrifstofur Kópavogs flytja í áföngum á árinu 2017 og var stærstur hluti stjórnsýslu- og menntasviðs fluttur í ágústbyrjun.

Vegna flutninga stjórnsýslunnar úr Fannborg auglýsti Kópavogsbær eftir áhuga þróunarfélaga, fjárfesta, byggingarfélaganna og annarra á kaupum á fasteignum í Fannborg í Kópavogi. Bæjarstjórn samþykkti að hefja opið söluférlu fasteignanna Fannborg 2, 4 og 6. Kópavogsbær mun samhliða sölu fasteigna skoða möguleika á að gera breytingar á skipulagi svæðisins sem gæfu möguleika á að byggja nýtt húsnæði á svæðinu.

Mjög góð þátttaka var í sumardvöl dægradvala við grunnskóla Kópavogs. Boðið var upp á sumardvöl frá 9. ágúst til og með 18. ágúst en hún er fyrir börn sem eru að hefja skólagöngu í 1. bekk. Markmiðið með dvölinni er að stuðla að vellíðan, öryggi og jákvæðri aðlögun nemenda, jafnt félagslega sem námslega að umhverfi grunnskólanna áður en formlegt skólustarf hefst.

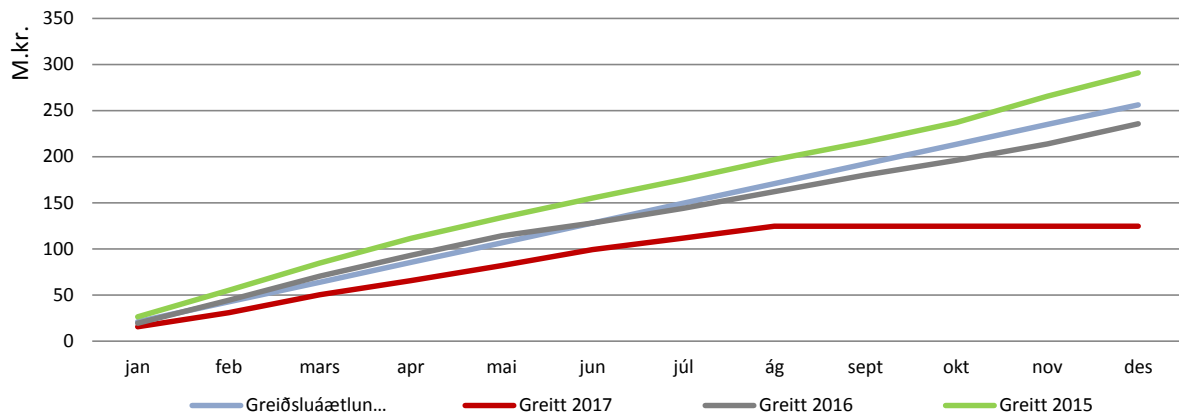
Grunnskólar Kópavogs voru settir 22. ágúst. Tæplega 5.000 börn skólunum veturinn 2017-2018, þar af 500 í fyrsta bekk.

Tilkynnt var um ráðningu í nýtt starf hjá Kópavogsbæ, stöðu sérfræðings í lýðheilsumálum. Anna Elísabet Ólafsdóttir var ráðinn í starfið en hún mun fylgja eftir nýsettri lýðheilsustefnu bæjarins.

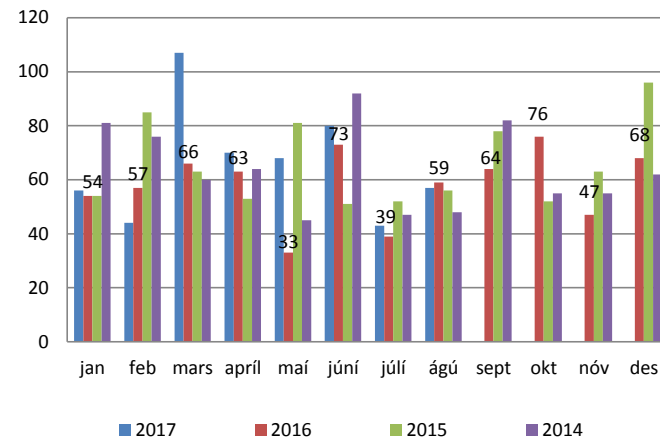
